“PLAYER NOMINATION AGREEMENT”

1. Player must be a registered, financial member of a Club affiliated with PRNA and/or Netball QLD and must comply with Netball Queensland’s ruling to the number of games played prior to commencement of the competition.
2. Players must be registered in the current Winter Day season competition to be eligible to nominate for any PRNA Rep. Team. Players must play a minimum of three (3) competition games to be eligible to participate at a Netball QLD Championship and/or Carnival.
3. The player must abide by the rulings of PRNA, Team Coach and/or Manager.
4. The player must attend training sessions as organised by the Coach and/or Manager.
5. If the player is unable to attend any organised training session, she must notify the Coach and/or Manager, prior to the training session and state the reason for being unable to participate.
6. The player must pay all costs as set by PRNA in relation to participation in any PRNA Rep. Team which includes any levies, travel costs, accommodation and uniform costs.
7. The player must participate in all fundraising activities as organised by PRNA for any Rep Team.
8. The player must pay all nomination fees applicable to PRNA in connection with any Rep Team selection by the date stipulated by the Association. Clubs are responsible for collecting the nomination fees.
9. The player must at all time, whilst attending Championship/Carnivals as a member of a PRNA Rep Team wear the Association uniform correctly, neatly and proudly.
10. The player/parent/guardian must complete in full, the “Health Chart Form” and return to the Team Manager by the date stipulated.
11. The player must supply a Doctor’s Medical Certificate if asked by PRNA. This relates to any injury or illness which may give concern as to the selected Rep Player’s fitness to complete in competition at representative level.
12. The player must provide a written letter advising their inability to attend any selection trial, a **minimum of 24 hours** prior to the final selection day, to **the Secretary of PRNA only**. Selection of a player who is absent from final selection trials into a PRNA representative team will be at the discretion of the Selection Committee, and selection cannot be automatically assumed.
13. Nomination fee will only be refunded if not selected in first squad. No nomination fee will be refunded if selected in the second squad and/or team. No nomination fee will be refunded if the player fails to attend squad selections without notice in writing to **the Secretary of PRNA** 24 hours prior to the commencement of trials. **NO EXCEPTIONS.**
